TERMS & CONDITIONS

1. 30% deposit to be paid at time of booking and remainder to be paid eight weeks before arrival (for late bookings, ie later than two months before, the full amount will be paid at time of booking). This must be sent together with completed booking form. Cancellation will result in the loss of deposit and liability of complete cost. If we are able to re-let the period, or part of the period booked then liability will only occur on the part period unlet or no liability if the whole period is re-let. Deposit in each case will be lost.
2. We ask for a damage deposit cheque of £50 which will be returned to you within 2 weeks of your departure providing no damages are discovered. A separate cheque for this should be sent with the balance of your holiday.
3. Bookings run from Saturday to Saturday. Please note that the gite is available after 4.00 pm on the day of arrival and we kindly ask you to vacate before 10.00am on the day of departure.
4. Linen is provided but beach/swimming towels are not. For lets of two weeks or more linen will be changed once a week on Saturday. We ask that towels provided are not used around the swimming pool or taken to the beach.
5. A cot and high chair are available but bedding for the cot is not provided. Please let us know prior to your arrival whether you require the use of the cot or high chair.
6. The pool is there for your pleasure but at your own risk and all children under the age of 14 must be accompanied by an adult. It is law in France for swimming pools to conform to some security issues. Our pool is fitted with an alarm and we will instruct you how this functions on your arrival.
7. Please also use plastic glasses around the pool.
8. All breakages and damages must be reported and must be paid for.
9. The owner's insurance does not cover the party's personal belongings, public liability etc. You are strongly recommended to take out appropriate insurance.
10. Smoking is not permitted inside the gite or house.

We believe this is your holiday and therefore do not want to make rules and regulations, however of those few conditions we do make we ask for your fullest co-operation and to leave the accommodation in the same tidy and clean condition as it is found.

We hope that you fully enjoy your stay at La Blanchetterie and please let us know if there is anything we can help you with either before or during your stay.
